Board Member Job Responsibilities

- 1. Serves a minimum of 1 three-year term on the Board. Eligible to serve 2 three-year terms.
- 2. Attends board meetings on a regular basis. Currently, the 2nd Tuesday of every month from 8 -9 am at the Chamber.
- 3. Act as a Liaison or participant on a Chamber committee.
- 4. Volunteers a minimum of 6 hours at Liberty Fall Festival.
- 5. Stays informed about committee matters, prepares for meetings, and reviews and comments on minutes and reports.
- 6. Make a serious commitment to participate/attend Chamber sponsored events.
- 7. Participates in the committee's annual evaluation and planning session held in November.
- 8. Participates in membership recruitment for the organization.
- 9. Participates in fundraising for the organization.
